- I echo my colleagues' thoughts on the budget. It is difficult, probably the most difficult one I have worked on and there is a lot more to do.
- Coach Fitch, have you thought about talking to Cross Fit.
- I was listening to the radio last Thursday and I heard Mayor Rey put on quite a show, he is a radio star.
- My Uncle Bob Barges, a WWII veteran, just passed away.

I am just happy to be here.

Mayor Rey

- l echo all the comments my colleagues said. I'm looking forward to us going back and see what else we can trim. I think it is prudent that we make sure our citizens know that a lot of legislative changes have impacted this current budget and future budgets. Please make sure you are mindful of that. No matter what your feelings may be about the sweepstakes machines, we lost close to \$150,000 in our budget. The General Assembly just passed the business franchise tax that will cause us to lose \$9,000 from this budget and \$40,000 in next year's budget. That is almost \$200,000 in revenue that the city used to get and no longer get. The cost of doing business has gone up and that means it goes up for the city as well. I just want our citizens and businesses to be mindful of these facts. You can see the impact that the General Assembly has already had on Spring Lake. We have tightened our belt; we started with \$1.3M in the hole and have already cut \$1M from it. We are now looking to cut another \$300,000 to meet our obligation. That may come in the form of cutting the cost of living increase, a tax increase or fund balance. The Board is committed to making that decision without sacrificing safety. We have been elected to make hard decisions and we are committed to that.

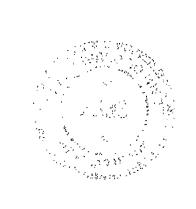
