7. Public Forum

Mr. Gary Dobson, 404 Virginia Drive, about the speed limit on Weaver Street and requested it be changed to 10 MPH. The Town recently placed a speed limit sign on Weaver Street for 25 MPH and stated that speed cannot be done safely. Alderman Christian stated he will follow up on this.

8. Public Hearing

d. Presentation, Certificate of Appreciation, Meter Readers

Mayor Rey and Mrs. West presented the meter readers with certificates of appreciation for their diligence, dedication and initiative in performing their daily duties. Dameon Johnson, Del O'Toole and Greg Thomas were honored for their hard work.

e. Presentation, EDC Quarterly Report

Mr. Hunt gave the Board a quarterly report from the Economic Development Corporation. He stated this update will focus on the overall vision of Economic Development in Spring Lake. More than a year ago the EDC did a Main Street Master Plan which includes a Façade Improvement Program, Street Scape Plan, Main Street Overlay District, the formation of a Main Street Business Association and Special Assessment District Creation. There have been two grantees that received a Facade Improvement grant, The Professional Building and the Asian Grocery Market. Mr. Hunt stated the Chamber's budget request to fund the Façade program was denied, causing this program to be put on hold. The Chamber Board and the EDC Board is speaking with Commissioners and Manager from Cumberland County in hopes of a commitment to make a budget amendment to fund the program. If funded, they plan to reduce the grant amount to \$5,000 to enable them to help more businesses on Main Street. He spoke about the Street Scape portion of the Main Street Master Plan. The estimated cost for the Street Scape Plan is \$800,000 which has been submitted to NC DOT. The plan includes resurfacing Main Street, expansion of existing sidewalks, paver bricks to create pedestrian walk ways, create a landscaped gateway on Spring Avenue and install directional signage. He also provided information on the Main Street Overlay District. He stated there are two developers interested in building multi-use buildings on Main Street once the Overlay District is approved. He stated if we do not restrict Main Street to certain districts we will never change the look and feel of Main Street. He stated he would like to create a Main Street Business Association which would be a subsidiary of Spring Lake EDC. He would like to create a Main Street Special Tax Assessment District at some point in the future to help

put money back into Main Street. Other municipalities have done this in North Carolina: Dunn, Holly Springs, Fuquay-Varina and Hope Mills. All funds collected from this special tax goes back into Main Street to help with redevelopment. He reminded the Board that about a year ago they created a Neighborhood Revitalization and Stabilization Area (area includes Weaver Street, Riverside MHP to the Mutzberg property and the Balsawood project) to help bring more resources to that area. In a short period of time a storage facility has been constructed, Balsawood subdivision is under construction, there is a proposal to redevelop the former Riverside MHP and 18 acres off of McNeil Street. Community Development Block Grants are available for the Neighborhood Revitalization and Stabilization Area. Mr. Wellons is proposing to develop a professional complex on Third Street. RLM's Phase 3 development is under construction with plans to purchase the remaining 23.8 acres in the Industrial Park. A new strip mall is planned for the old Shell gas station on Hwy 87 north of Spring Avenue. There is interest in a Short Stop or Dunkin Donuts coming to the old tobacco shop on Highway 87 at Manchester Road and finally, discussions with Fort Bragg are taking place to acquire additional acres along Highway 87 and annexing Linden Oaks.

Alderwoman Sutherland thanked Mr. Hunt for his hard work. She stated she would like to see us focus on one thing at a time. She is glad we are focusing on all of Spring Lake. She requested as Mr. Hunt speaks on these projects he include the Board as they have been trying to work on them as well. Collectively we can work as a team and get where we want to go in the future. She inquired about the funds that were denied from Cumberland County. Mr. Hunt stated since he has been here, the Chamber has requested grant funds every year from Cumberland County, just like Hope Mills and Fayetteville. This year, the County decided to only fund the Fayetteville Chamber's request. He stated he requested \$75,000 which is more than we traditionally request. In years past the Spring Lake Chamber has requested \$35,000 but because they have done so well, he increased his request. He stated the EDC is committed to raising \$100,000 in seed money. Alderwoman Sutherland asked about the developers who are interested in building on Main Street. Mr. Hunt advised FDR and Bragg Hospitality who are government contractors. Alderwoman Sutherland cautioned telling people things before they are certain because they look forward to something that might not happen. She again, thanked the EDC and her colleagues for their visions for the Town.

Alderman Christian stated he spoke with Lexi from CEED and suggested the EDC look at partnering with CEED. He also suggested forming a Merchant's Association. Mr. Hunt advised that Suzy Hrabovsky, CEO of CEED is on the Spring Lake Chamber Board.

Mayor Rey inquired about what Mr. Hunt said about Dunkin Donuts (stated in jest) he said I tweet with Dunkin Donuts every day. Mr. Hunt advised there is interest from Dunkin Donuts and Mayor Rey again in jest stated that interest is coming from the tweeting, and said he just wants to put that out in the universe and stated that he did not leak that one. Mayor Rey stated he appreciates the

efforts of the EDC and the Board and it takes everyone to make something happen. He said clearly my tweets are not bringing businesses to Spring Lake but it is all of our efforts and making sure the people know they can do business here in Spring Lake. I appreciate the Board who continues to be out in the community championing Spring Lake. We need to continue to partner with organizations like CEED. We will do what we can politically to get the resources back for Spring Lake. Continue the hard work, we look forward to the next quarterly report and hopefully I won't leak too much stuff out there. Mr. Hunt stated "you do you Mr. Mayor" and Mayor Rey replied "oh I will, don't worry, I was just saying that to put it on the record." All stated in jest.

c. Board to Consider KaBOOM Grant Application

Ms. Elder-White and Leslie Gilliams, Community Blueprint Representative, advised KaBOOM is a community built playground. KaBoom sends a project manager to the community to help the community get organized and to help the day of the event. The Recreation Advisory Committee has taken a lead on this and will coordinate the volunteers. The Town will have to provide approximately \$13,000 and all the volunteers. We will be partnering with our community leaders. Ms. Gilliams stated Community Blueprint is a national initiative for military communities and local

communities who service military personnel. Fayetteville Urban Ministries is a partner as well and the military. She stated she hopes to bring in some of the local businesses. Ms. Elder-White advised we will need a long term agreement with Cumberland County Schools for the property where they want to put the structure (behind the school in Woodland West.) They will apply for a Home Depot grant for \$5,000 and Ms. Gilliams will be looking for other grants that are available to help keep the Town from using tax funds for this project. Contributions can be made to the Town noted it is for KaBOOM and would be tax deductible. Ms. Elder-White advised if application is approved it will take approximately 2 months until playground is constructed and hopes to have it by the fall of this year.

Alderwoman Sutherland thanked Mr. Metcalf for not forgetting about this as she introduced it to him a few years ago. She is very happy and looks forward to many volunteers who will help make this happen.

Action: The Board approved a motion to move forward with the grant application for KaBOOM.

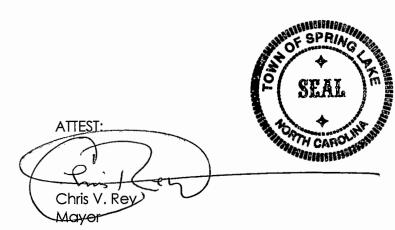
having a movie theatre before it was supposed to happen, I apologize for that, but I think it is in good taste that people know we are moving forward and that we have things coming to our community.
