Subject: Declaring Surplus Property for Sale

Overview:

The Town of Spring Lake Fire Department's inventory includes a 2008 Pierce pumper fire truck. In 2019 we ordered two (2) new engines to help with replacing the one (1) engine at the main station and put one (1) at the new station in Manchester area. We would like to sell the 2008 Pierce pumper to help pay for the equipment that the new engines require as well as help with the first payment for the new engines. The 2008 Pierce has been on Brindlee Mountain website for 6 months and we now have a buyer that is interested in purchasing the apparatus. The following proposal would allow the town to sell the surplus apparatus.

Recommendation:

Approve Resolution (2020) 4 authorizing the declaration of the 2008 Pierce Pumper as surplus and authorizing the sale of the apparatus.

A Resolution of the Board of Aldermen of the Town of Spring Lake, North Carolina; Declaring Surplus the 2008 Pierce Pumper Fire Truck (Apparatus)

- WHEREAS, it is the intent of the Town to sell the surplus 2008 Pierce Pumper to Gardnerville Fire Department, NC for \$185,000; Minus 7% (\$12,950) Commission Fee to Brindlee Mountain, whom has marketed this apparatus for the past (6) Months; Remaining balance \$172,050;
- WHEREAS, the 2008 Pierce will be sold "AS IS", "All Sales Final", cash or certified check only;
- WHEREAS, in 2019, (2) Two New Fire Engines were "Approved" and ordered; (1) One to cover the new Fire Station 11 in Manchester area; and the other to replace the 2008 Pierce Pumper Fire Truck currently servicing Station 22 in Spring Lake area;
- WHEREAS, the new trucks "do not" come "Pre" equipped with the necessary/required tools of operation; therefore, a portion of the sales revenue minus the commission fee will be used to reinvest in the purchasing the necessary/required tools of operation for both engines;
- WHEREAS, the balance of the remaining funds after purchases, will be applied to offset the (1st) first payment on the new Fire Engines;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE TOWN OF SPRING LAKE, THAT:

- Section 1. That the Board of Aldermen of the Town of Spring Lake do hereby declare the 2008 Pierce Pumper Fire Engine a "Surplus" item.
- Section 2. That the Board of Aldermen of the Town of Spring Lake do hereby authorize the aforementioned "Approval" for sale to Gardnerville Fire Department, NC.
- Section 3. That Town staff is hereby authorized to execute any and all documents associated with the transfer/Sale of the 2008 Pierce Pumper Fire Truck to Gardnerville Fire Department, NC or eventual purchaser.
- That the Board of Aldermen of the Town of Spring Lake do hereby authorize the purchase of necessary/required tools of operation for the (2) Two new Fire Engines; and use the remaining funds to "Offset" the (1st) First payment on the New Fire Engines.
