Business

NCDOT Update

Gregory Burns discussed Bragg Blvd sidewalks and why there was a delay due to having water pumps installed. Now, DOT is waiting for Duke energy to make an electrical connection. In addition, DOT is installing a pedestrian walk NC24 AND NC210. Mr. Burns stated they are working on improving safety in the Spring Lake area. Mr. Burns said they are working on closing up the gaps on the roads. He said they are working on getting more road warning signs and pedestrian signs. Mr. Burns said the funds are coming from the U4444 Project funds and CAP 88. The recommendation is installing a crosswalk and pedestrian signal at Bragg Blvd and NC210 Hwy. He said its already under contract. Mr. Burns stated a flashing crosswalk signal be installed at 4th Street, and Holland Street will have a pedestrian crosswalk and sidewalk added from Bragg Blvd and over to Monroe Street. Mr. Burns said that they will widen about 10 feet on the roundabout so they can install a sidewalk for the pedestrians. Mr. Burns said there will be lights along Poe Street and bridge. He stated they are working on Manchester Road intersection to help with traffic flow. It's scheduled for 2023. Aldermen O'Garra thanked Mr. burns for helping Spring Lake and asked if the Town is paying for the contracts? Mr. Burns said no, the funding is coming from them. Alderwoman Cooper asked about

the resolution that dealt with the speed limit being reduced to 40mph. Mr. Burns asked had the resolution been sent to DOT, if so, then they would take that in consideration. Mr. Burns said they did add reduce speed signs when coming in to Spring Lake area. Mr. Burns recommendation was to add "Welcome To" signs to help reduce the speed. That would help make people aware when coming into town. Alderwoman Sutherland asked about opening Spring Ave back up for public safety? Alderwoman Sutherland concerns about crosswalk on NC210 and to get to Main Street and NC87 to get to Wal-Mart putting in a pedestrian crosswalk as well as Deerfield subdivision. Alderwoman Sutherland concerned about some people don't have vehicles. Mr. Burns explained there will be crosswalks installed at NC87, NC210, NC24, and Bragg Blvd. Alderwoman Sutherland asked about Sleepy Drive. Mr. Burns said there will not be a crosswalk. Alderwoman Sutherland concerned about even if a pedestrian pushed the button crosswalk and what will let a driver know to slow down? Mr. Burns said there is a sign and flashing yellow light. Mr. Burns said once they press the button there will be yellow flashing light. Mr. Burns said it does not stop traffic, it will advise them.

Ms. Webb asked for the Board to approve and adopt the 2020 Holiday schedule. Ms. Webb stated the 2020 Holiday schedule mirrors the holiday schedule for the employees of the State of North Carolina with the exception of the Town's addition of President's Day and omission of one of the three days that State receives during the Christmas Holiday period.
