**4. New Business**

**Resolution (2020) 4, Declaring Surplus Property and Authorizing Sale, Fire Department**

Chief Williams asked the Board for approval to sell the 2008 Pierce pumper fire truck as surplus, and to help pay for the equipment that the new engines require as well as help with the first payment for the new engines and we won't have to use any of our funds. Chief Williams stated the 2008 Pierce has been on Brindle Mountain website for 6 months and we now have a buyer that is interested in purchasing the apparatus. The Gardnerville Fire Department (about 2 hours away) is purchasing the fire truck. We are selling the 2008 Pierce pumper truck for \$185,000 and we have to pay seven percent (\$12,950) to Brindle Mountain for listing and that will leave us \$172,050. This will help pay for the items that are required on the new trucks, and the remaining money would go toward the first payment on the new trucks.


