#### b. Quarterly Finance Update

Mr. Watson provided the Board of Aldermen with an overview of the Financial Comparison Analysis for each Fund and stated we are right on track for expenses and revenues and some Funds that appear to be lagging in an area will show a closer gap as the Fiscal Year progresses. However, the Town's revenues are higher than its expenses and that is what we want to see. Mr. Watson reviewed the Quarterly Investment Report, the Summary P-Card Use by Month Report and the Summary BB&T Card Use by Month Report.

#### c. Manager's Update

Mr. Davis reported the following:

- Chief Kimble was appointed to The North Carolina Sentencing and Policy Advisory Commission; this speaks highly of Chief Kimble and his qualifications to serve on a State level Commission.

- FEMA reimbursement update: We have submitted our reimbursement requests and expect to begin

- Saturday, April 29, 2017 beginning at 10 a.m., Chief Kimble will be put on the roof of Walmart and not allowed to come down until he raises \$1,000 for the North Carolina Special Olympics.
