Alderwoman Cooper asked do we have a town representative who attends meetings? Mrs. Wullenwaber stated she attends the meetings. Alderwoman Sutherland had concerns about the bylaws, and a person serving on the Board of Directors. Alderman O'Garra had concerns about the town attorney reviewing the documents. Mrs. Wullenwaber stated yes, Mrs. Catherine Bamba reviewed the revisions. Mrs. Bamba stated yes, and the Board can approve or deny the bylaws.

Mayor Dobbins administered the Oath of Office to Ms. Melissa Pereira as Town Clerk for the Town of Spring Lake.

## d. Discussion of Utilization of the Recreation Center

Alderman O'Garra questioned why he couldn't use the Recreation Center on Thanksgiving to feed the town citizens. Alderman O'Garra stated there were over 500 people who were fed last year in Spring Lake. Alderwoman Jackson expressed her concerns about feeding the town's citizens, and the utilization of the gym to aid in providing a Thanksgiving meal. Alderwoman Cooper provided details that they have secured a location at Rustic Burger to feed Thanksgiving meals to town citizens. Mayor Dobbins stated the Interim Town Manager made a decision, and the Board tasks the Interim Town Manager to make decisions. Mayor Dobbins explained to the Board they cannot override the Interim Town Manager because the Interim Town Manager legally makes those decisions to determine the use of the town's facilities. Mayor Dobbins stated if a person gets hurt in one of the town's facilities; this town would suffer the consequences. Mayor Dobbins stated the Interim Town Manager is tasked to run the day-to-day operations of the town.
