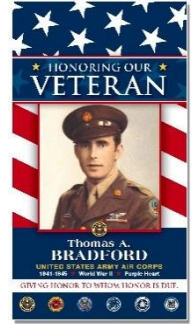

requirements have not been met. The Town of Spring Lake will give the banner back to the applicant after the Display Period. If the applicant chooses to return the banner the following year to be displayed, it must be inspected to meet the requirements.
